



Respiratory Function Grading (RFG) Scheme Entry Criteria for Crufts 2025

Frequently Asked Questions

1. What is the RFG Scheme, and why is it required for Crufts 2025?

The RFG Scheme is a health screening assessment designed to evaluate the respiratory function of Bulldogs, French Bulldogs, and Pugs. This requirement aims to ensure that dog shows remain an effective platform to monitor and improve dog health.

2. Which dogs are required to have a valid RFG Scheme certificate?

All Bulldogs, French Bulldogs, and Pugs exceeding 14 calendar months on the first day of the show must have a valid RFG Scheme certificate to attend. Dogs under 14 calendar months on the first day of the show are exempt from this requirement. Dogs 7 years or older on the first day of the show are not required to have a certificate dated within the last 24 months. However, they must have undergone at least one RFG Scheme assessment in their lifetime. If no prior assessment has been completed, the dog must obtain one before entering the show.

3. What does “valid” mean for an RFG Scheme certificate?

A valid RFG Scheme certificate must be dated within 24 months of the first day of the show.

4. Are there any entry restriction for Bulldogs, French Bulldogs, and Pugs?

Bulldogs, French Bulldogs, and Pugs with a Grade 3 assessment will not be permitted to enter the show.

5. How do exhibitors submit their RFG Scheme certificates?

Exhibitors must upload their RFG Scheme certificate to their Fosse Data account and complete the requested information. The Kennel Club will validate the certificate, and exhibitors will be notified if it has been approved or rejected.

To upload a certificate, navigate to the **‘My Account’** section on the Fosse Data website and select **‘Upload RFG Certificate.’** Follow the on-screen instructions, an example is shown below for your reference.

6. How long does it take to validate an uploaded certificate?

Certificates will typically be reviewed and validated within 24 working hours. However, exhibitors uploading certificates close to the entry deadline may experience longer processing times due to high demand.

7. How do I obtain a copy of my dogs RFG Scheme certificate?

A copy of the RFG Scheme assessment certificate should have been given or emailed to you at the time of your assessment. If you have misplaced or can not locate the certificate, please contact health@thekennelclub.org.uk for a free digital copy.

8. What happens if a certificate is not uploaded or approved in time for the entry deadline?

Exhibitors are strongly encouraged to upload their certificates as early as possible to allow sufficient time for validation. Delays in uploading certificates close to the entry deadline may result in missed opportunities to complete the entry process.

9. Can exhibitors proceed with entry if their certificate is still under review?

No. Exhibitors can only proceed with their entry once their certificate has been validated and approved by The Kennel Club.

10. Are overseas exhibitors subject to the same requirements?

Yes, international exhibitors must meet the same standards. Assessments conducted in RFG Scheme licensed countries by approved assessors will be accepted. If an overseas RFG Scheme certificate is unavailable, exhibitors must arrange an assessment in advance of the show. Testing facilities will be available at The Kennel Club Building, Stoneleigh Park on Wednesday, 5 March, and Thursday, 6 March 2025. Exhibitors must book an appointment in advance by contacting health@thekennelclub.org.uk.

11. What testing facilities are available for those without a valid certificate?

RFG Scheme assessments will be provided at The Kennel Club Building, Stoneleigh Park, on Wednesday, 5 March, and Thursday, 6 March 2025. Exhibitors must book an appointment in advance by contacting health@thekennelclub.org.uk.

12. What if my dog receives a Grade 3 assessment?

Dogs graded as Grade 3 will not be permitted to attend or compete in the show. If this occurs during an assessment after entry or at the event, the exhibitor must withdraw their entry.

13. Are other international assessments or a letter signed by my vet accepted?

No, only assessments conducted under the Kennel Club/University of Cambridge Respiratory Function Grading (RFG) Scheme will be accepted. These assessments must be carried out by an approved assessor either in the UK or in a licensed country. A letter or other international assessment signed by a veterinarian, regardless of assessment type or location, will not meet the entry criteria.

14. Are dogs aged 12–14 months required to have an RFG Scheme assessment?

No, dogs aged 12–14 months are exempt from the mandatory requirement. However, exhibitors are strongly encouraged to take advantage of the testing facilities at Crufts.

15. Do Bulldogs, French Bulldogs, and Pugs not competing in breed showing still require an RFG Scheme assessment?

Yes, all Bulldogs, French Bulldogs, and Pugs exceeding 14 calendar months on the first day of the show, whether competing in breed showing, participating in other disciplines, or simply present at the event, will require a valid RFG Scheme assessment.
